COVID-19 and Criminal Justice

2020, began like any other year, full of promise and exciting possibilities. Then, the second week in March turned Ohio and the International community upside down. We were faced with an unprecedented threat called Coronavirus, or COVID-19. Medical experts from the Center for Disease Control and the World Health Organization declared COVID-19 a pandemic, the likes of which the world has not experienced since the 1918 influenza pandemic.

In the best of times, the criminal justice system grapples with the challenges of prison and jail overcrowding, a heroin epidemic, mental health crisis, budget constraints, and a legislative directive to address community reentry and supervision issues. Today, these systems are confronted with unique challenges as they work to mitigate the risks of COVID-19 for incarcerated people, correctional staff, and those working with individuals returning and living in the community.

There is no doubt, the criminal justice system is navigating uncharted waters and the keys to crossing these waters safely and appropriately requires collaboration and input from all of our criminal justice partners. However, in the midst of these challenges, also lies an opportunity to reconsider policies and procedures introduced during the previous decade. These reforms include, but not limited to evidence-based decision making, bail reform, data collection, data-sharing, and emphasizing rehabilitative and restorative justice aspects for juveniles and adults.

Moreover, the need to provide access to the justice system during social distancing has the legislature and the judicial branch re-examining the vitally important role of technology in our courtrooms, adult and juvenile correctional facilities, parole and probation offices, as well as within community service organizations, and workforce development boards.

How community corrections will be affected by the decisions made during the COVID-19 pandemic remains to be seen.

Finally, on behalf of OJACC, I want to extend our gratitude and appreciation to all of Ohio’s correctional staff, community corrections, probation, courts, and law enforcement for coming to work every day never knowing if today will be the day that changes their lives and their family’s lives for the foreseeable future.

Response to COVID-19 by Criminal Justice Systems

Governor Signs TeleHealth Executive Order

Ohio Governor Mike DeWine [signed an executive order](#) that will allow Ohioans to more easily access telehealth services from individual counselors, social workers, and marriage and family counselors. In normal circumstances, a patient must have had a face-to-face first meeting and counselors and social workers before qualifying for a telehealth appointment; the providers would also be required to take special training in providing telehealth services. This order will enable those requirements to be removed so that patients can more easily access these needed services. "Mental health is just as important as physical health, and in this time of social distancing and stay at home orders, we are trying to ensure that those who need services can access them without leaving their homes," said Governor DeWine.

Many have reached out to the UCCI team about how to continue delivering quality services during the COVID-19 pandemic and social distancing requirements. In this way, we offer these general guidelines and resources to support your continued efforts through these extraordinary times.

Community-Based Services

Thank you for your dedication and continued efforts during this period of uncertainty. While public safety continues to be our number one priority, sometimes the best way to reduce reoffending is to remove barriers. In these times, remember that it is acceptable to focus on a person's basic needs. The economic impact of COVID-19 will likely affect many people under supervision, so providing education around government responses and resources may be necessary. While some sessions may involve practicing emotion regulation skills, others will focus on crisis intervention rather than criminogenic needs.

Many will use alternate methods such as phone or video to maintain contact with individuals on their caseloads. If you plan to remotely deliver group interventions, preferably choose options with video so that you are able to monitor role plays and other practice opportunities and provide constructive feedback. In-Custody Services

Thank you to those individuals who continue to maintain safety, security, and programming in jails, prisons, and residential facilities. As we adjust to this "new normal", please consider the following CDC recommendations around social distancing and group activities from <https://www.cdc.gov/coronavirus/2019-ncov/community/correction-detention/guidance-correctional-detention.html>

- Limit the size of group activities
- Increase space between individuals during group activities
- Suspend group programs where participants are likely to be in closer contact than they are in their housing environment
- Consider alternatives to existing group activities, in outdoor areas or other areas where individuals can spread out
- Note that if group activities are discontinued, it will be important to identify alternative forms of activity to support the mental health of incarcerated/detained persons.

For over 30 years, OJACC has brought together Ohio's criminal justice stakeholders to include judges, defense attorneys, prosecutors, pre-trial and probation officers, law enforcement officials, corrections officials from adult and juvenile systems, treatment providers, reentry practitioners, and victims' representatives to promote and support effective community corrections that enhance public safety. Few other states have this type of umbrella organization, and ours represents Ohio's collaborative efforts that have led to Ohio's place as a leader in Community Corrections.

Together we:

- Hold a biennial board retreat to focus efforts of the organization and guide our mission.
- Host a biennial legislative reception with OJACC member organizations to educate legislators on issues vital to the improvement of community corrections. OJACC also takes positions throughout the year on pending legislation effecting community corrections and provides input on the development of legislation.
- Work with state agencies on policy affecting community corrections.
- OJACC's Adult Community Corrections Collaborative, comprised of associations providing state-funded community corrections services, work with the ODRC for the overall improvement of these services and assist in preparing an annual Fact Sheet highlighting benefits and cost savings of community corrections.
- Hold an annual conference to educate and inform service providers and stakeholders on issues of importance to community corrections and provide tools to enhance services.

Individual Membership \$25 - Allows an individual in the field of criminal justice or interested citizens to join. Individuals representing private for-profit corporations are excluded from this category.

County Membership – Allows *county commissioner, judge, prosecutor, chief probation officer and sheriff* from a county to join. These offices may designate an employee from that office to represent them, but are specific to the listed positions. **Five** members from the county receive a \$25 discount for annual conference fees. **For counties with a population under 150,000, membership is \$150 and counties with a population of 150,000 or greater, membership is \$250.**

Government or Private Agency – Allows governmental or private, not-for-profit agencies to join. Membership extends to the director of the agency or the designated employees. Examples of private agency members are halfway houses, private correctional agencies and child caring agencies. Examples of Governmental Agencies include state agencies, courts, CBCFs, Probation Departments. **Three** members from the agency receive a \$25 discount for annual conference fees. **For agencies with a budget of less than \$500,000, membership is \$150 and agencies with a budget of \$500,000 or greater, membership is \$250.**
