WHAT MAY CHANGE IN 2017?

Legislative Update

The 132nd General Assembly began on January 3, 2017, and House Committee assignments were announced the week of January 12, 2017. Representative Jim Butler will be the chair of the Civil Justice Committee and Representative Nathan Manning will be the chair of the Criminal Justice Committee. Legislative sessions are scheduled to start on January 25, 2017, and the budget is due to be submitted to the House from the Governor's office on January 31, 2017.

Two topics of interest at the start of this General Assembly are the ongoing work of both the Recodification Committee and the groups working on medical marijuana implementation. The Criminal Recodification Committee, which was tasked with clarifying Title 29 of the Ohio Revised Code, was expected to complete its work in 2016. It has been authorized to continue its work through June 2017. Although a draft bill has been prepared, it has not been finalized and in the coming months the Committee will be reviewing more than 100 amendments that have been submitted by Committee members. HB 523 from the 131st General Assembly went into effect on September 9, 2016 and legalized medical marijuana in Ohio. The bill requires that implementation, under the Medical Marijuana Advisory Committee, be complete within a year of its effective date. The Governor's Office, as well as the Medical, Pharmacy, and Commerce Boards are currently working on regulations concerning medical marijuana and answers to questions about medical marijuana in the workplace, in vehicle operation, and in drug courts.

The OJACC Policy and Advocacy Committee stands ready to review the work of, and provide input to, both of these groups in 2017.



OJACC Celebrated Its 30th Annual Conference

30 Years – Promoting and Supporting Effective Community Corrections

The Ohio Justice Alliance for Community Corrections (OJACC) celebrated its 30th annual conference, “30 Years – Promoting and Supporting Effective Community Corrections” at the Crowne Plaza Hotel North in Columbus, Ohio, on October 13 and 14, 2016. At 30 years, we are still going strong with our most well attended conference to date.

The conference opened Thursday morning with Dr. Ed Latessa, Dr. Brian Lovins, and Michael Randle “Exploring the Past, Lessons Learned, and Opportunities for Future Success.” As our community corrections practitioners and stakeholders work diligently to continue to improve community corrections in Ohio, it is important to keep in mind how far we have come over the years. We thank our presenters for helping us reflect on the successes and challenges we have faced and assisting us to focus on the opportunities for the future as community corrections agencies solidify their role as agents of change, recognize that we cannot punish our way out of crime, continue to improve assessment and intervention with more effective monitoring and evaluation, and integrate technology into the daily work to improve efficiency and effectiveness. Our presenters discussed that the challenge is no longer what we should be doing; we now know what we should be doing. Our current challenge is ensuring we are doing it with quality, effectiveness, and efficiency.

Kimberly Gentry Sperber, Ph.D provided the closing session with an insightful presentation on “Factors Influencing Medication-Assisted Treatment in Ohio Halfway Houses and Community Based Correctional Facilities,” highlighting a study completed on this issue. Dr. Sperber reminded us that opiate overdose is the second leading cause of injury-related death nationally (surpassed only by car accidents) and, in Ohio, accidental overdose is the leading cause of death and has been since 2007. As a result of

the overall prevalence of opiates in our state, we treat and supervise a population at high risk for opioid addiction, overdose and death, and we have a responsibility to deploy evidence-based practices to the best of our ability. As a result of the study, efforts are underway to produce a practitioner toolkit for working with this population that will be available for use in the field. We will keep you posted on this effort.

Several workshops were also offered to address Ohio's challenging opiate-addicted population. Other workshops highlighted progress on jail diversion initiatives aimed at reducing the number of defendants with mental health issues in our jails, a lethality assessment program being used in intimate partner violence cases, overcoming barriers utilizing core correctional practices, working with offenders with intellectual disabilities, cognitive behavioral interventions for offenders seeking employment, and a juvenile workshop track, to name a few. Thank you to all of our presenters. Many of the presenters submitted electronic copies of their presentations which are available on the ojacc.org website.

OJACC would like to thank agencies who sponsored our 30th Anniversary Celebration, featuring live entertainment. Sponsors included Oriana House, Corjus, Inc., CourtView Justice Solutions, Redwood Toxicology Laboratory, Inc., The SASSI Institute, Inc., Ohio AMS, and Smart Start Ohio. Fun was had by all as evidenced by the included photo.

OJACC was also honored to continue its partnership with the Ohio Department of Rehabilitation and Correction (ODRC) as ODRC once again presented The Clifford Skeen Awards in conjunction with the OJACC Achievement Awards luncheon recognizing excellence in community corrections. 2016 OJACC Achievement Awards

Each year at the annual conference, OJACC recognizes individuals who have shown dedication to the improvement of community corrections. The 2016 OJACC Achievement Award recipients include:

The Honorable David T. Matia received the Representative C.J. McLin Award presented to an elected official in Ohio who has worked towards the improvement of community corrections.



Serving in his 18th year as a Common Pleas Court Judge, he started Cuyahoga County's first Felony Drug Court in 2009. Under his leadership, the Court expanded to a second judge led docket three years ago. Many new drug court judges tour Judge Matia's Court for guidance as they build their own programs. More than 300 individuals have graduated the drug court with a twelve-month recidivism rate of 8.4 percent. Judge Matia advocated extensively for Ohio's adoption of Medicaid Expansion and the benefit it would bring to the criminal justice system in its ability to treat those suffering from mental illness and/or dependency, and recently published an Op-Ed piece calling for a shift in how the medical profession treats dependency. He was also involved in securing grant funding to enable incarcerated defendants to receive their first dose of medication in County Jail prior to leaving for treatment to reduce cravings to be better able to focus on treatment.

Judge Matia has been involved in other efforts such as the Drug Drop Box Program and support of local programming. He received the 2016 Exemplar Award from Recovery Resources and has been recognized by the Cuyahoga County ADAMHS Board with a Community Collaboration Award. He also serves as President of the Ohio Common Pleas Judges Association, serves on The Ohio Attorney General's Opiate Task Force, and assisted in the formation of an ad hoc committee of judges and other decision makers with Director Gary Mohr of the Ohio Department of Rehabilitation and Corrections to tackle Ohio's prison population crisis.

Phillip Nunes received the Dr. Bennet J. Cooper Award presented to correctional administrator or policy maker who has shown a lifetime commitment to the improvement of community corrections.



Phil Nunes brings extensive experience totaling 27 years in management and non-profit operations. He currently serves as chief program officer at Alvis Inc. where he oversees state-wide programs operated by Alvis Inc. He is also responsible for new program development and projects the agency engages in state-wide.

Throughout his career, Phil has worked at the organization, state, national, and international level to promote the improvement of community corrections. He has served as president of the International Community Corrections Association, and president of the Ohio Community Corrections Association. He has served as an advisory member of the Ohio Criminal Sentencing Commission for many years and currently participates in the Ohio Criminal Recodification Committee. Phil is also past president of OJACC and served as co-chair for the Juvenile Justice Initiative for Voices for Ohio's Children. Phil has participated in the OJACC Community Corrections Collaborative since its inception and currently serves as co-chair.

On the national level, he has participated in the NIC Community Corrections Collaborative Network in which he contributed the paper, "Safe and Smart Ways to Solve America's Correctional Challenges."

Phil's dedication, passion and commitment to the field of community corrections has assisted with policy changes and legislative changes to promote the improvement of community corrections.

Veronica Perry received the Dr. Simon Dinitz Award presented to a community correctional practitioner who has made contributions to the improvement of community corrections in Ohio.

Throughout her career, Veronica has embodied leadership, wisdom and compassion for her co-workers and those under the Court's supervision. From the beginning of her career she was often tapped by those in administrative positions for her guidance and consultation. Veronica could always be counted on to provide solid, informed and forward-thinking advice and solutions.

Shortly after serving in the capacity of Probation Officer Supervisor with the Cuyahoga County Adult Probation Department, Veronica was selected to lead the Medina Court of Common Pleas, Adult Probation Department. In her current capacity of Director of Probation, Veronica acquired her Master's Degree in Justice Administration from Tiffin University, was an adjunct Criminal Justice Professor at Baldwin Wallace College, mentors Chief Probation Officers as they adjusted to their new roles, was accepted into the Court Managers' Program through the Ohio Supreme Court's Judicial College, and has significantly advanced her Court toward implementing evidence-based practices. She has developed and implemented many innovative and successful programs in her Court, including a robust training, development and continuous quality assurance program.

During these last several years, Ohio has seen some of its original community corrections leaders retire. These retirements have created opportunities for others to take the reins and represent the field in its national reputation of excellence. Veronica quickly accepted this challenge and assumed many of these leadership responsibilities. Some of these include becoming the Vice President, and now President, of the Ohio Chief Probation Officers' Association, co-chairing OJACC's Adult Community Collaborative, and chairing OCSS's Governance Committee. She is also an active member of the American Probation and Parole Association, The National Association for Probation Executives and sits on several criminal justice boards.

Veronica has positioned herself as an expert and leader in the field. She is a true collaborator and genuine friend and colleague.

Anne Connell-Freund received the James Wichtman Award presented to an OJACC Board Member who has dedicated themselves to OJACC's mission.



Anne has been a very active board member of OJACC for many years. She has served on the OJACC Community Corrections Collaborative and conference committee and served as OJACC President from 2014-2015. Her straightforward approach to leadership and commitment to quality services exemplifies the intent of this award.

Anne is the Executive Vice President of Operations for Oriana House, Inc. and is responsible for overseeing the overall operation and management of residential, non-residential and diversionary community corrections programs, cognitive skills, treatment, employment, and education programs as well as developing and implementing new programs, and continuous quality improvement. In addition, she supervises grants administration, project construction, and the research department. Anne's successful career with Oriana House began in 1989 as a caseworker coordinator and progressed to her current position as Executive Vice President of Operations.

Anne received her Bachelor of Science degree followed by her master's degree from The University of Akron. She served in active duty for the U.S. Army from 1977-1981, and worked as a Military Intelligence Analyst during her career as a Reservist from 1985-1992.

Anne is the recipient of the 2003 Professional Achievement Award from the Ohio Department of Rehabilitation and Correction, 2008 Leadership Award from the Ohio Community Corrections Association, 2008 Simon Dinitz Award.

Presently, Anne is the president of International Community Corrections Association (ICCA); past President of the Ohio Justice Alliance for Community Corrections (OJACC); as well as board member and past president of the Ohio Community Corrections Association (OCCA). Additionally, Anne serves on numerous statewide coordinating and collaborating committees for community corrections. She is also a Vice Chair of the Summit County Children Services Board in Summit County, Ohio.



Ohio Department of Rehabilitation and Correction's 2016 Clifford Skeen Awards

The Ohio Department of Rehabilitation and Correction held the 24th annual Clifford Skeen Awards Ceremony on October 13, 2016 during the annual Ohio Justice Alliance for Community Corrections (OJACC) conference at the Crowne Plaza North in Columbus.

This award is given in honor of the late, eight-term Ohio Representative, Clifford Skeen, who sponsored the Community Correction Act passed by the Ohio Legislature in 1979. The purpose of this act was to reduce the number of non-dangerous offenders being sent to state prisons. Representative Skeen was instrumental in obtaining increased funding for many community corrections initiatives. The Clifford Skeen Award was initiated in 1993 to demonstrate commitment to community corrections as a viable alternative to incarceration.

ODRC Director Gary Mohr spoke before the awards were presented, emphasizing the important role that community corrections programs play in assisting the Department to achieve its goal of reducing the prison population. He also acknowledged the efforts that all of Ohio's community corrections programs make in working with offenders to better their lives while keeping our communities safe and thanked attendees for their ongoing efforts that make Ohio a leader in national and international community corrections.

The selection committee was comprised of last year's Cliff Skeen recipients represented by Jason McGowan, Chief Probation Officer of Pickaway County Municipal Court, Mike Randle, Deputy Director, Oriana House, Eddie Philabaun, Executive Director of STAR Community Justice Center and Lois Hochstetler, Managing Director, Alvis. They recommended the award recipients after conducting individualized interviews of Ohio's top scoring programs in each category. The panel selected the following programs as the 2016 Clifford Skeen Award recipients:



Community-Based Correctional Facility: Lorain Medina CBCF



Halfway House: Alvis House Jackson Pike



Prison Diversion Program: Marion County Adult Probation Department

History of OJACC

The vision for OJACC (Ohio Justice Alliance for Community Corrections) resulted from a group of community corrections professionals coming together with involved state agencies to address the rising prison population in the early 1980s. This group saw real value in bringing together all aspects of community corrections to work toward common goals.

The association began with an initial advance of \$1,000 from the Ohio Halfway House Association (Ohio Community Corrections Association) and, in addition to the officers, included committee representation from Secure Facilities, Residential Facilities, Victim Witness, CCA Programs and Probation. It did not take long to realize there are many more influences to community corrections than those initially involved and, over the years, additional representatives from associations and state agencies have been added to truly represent the big picture of community corrections. With this diverse representation, we have not always agreed on everything. However, it has truly provided an understanding and respect of the work that goes into all areas of community corrections. Over the years, we also identified the need to include the issues of Juvenile Justice.

This type of association is not something that happens in many other states. Our ability to work together among community corrections agencies, DRC, DYS, and other state agencies and stakeholders has assisted Ohio in becoming a leader in community corrections. By focusing on our common goals of improving community corrections, we learn from each other and learn to work together.



The original name of OJACC was OCCO (Ohio Community Corrections Organization). In 2005, the board voted to change the name of the association from OCCO to OJACC. The board decided on a name change that could better reflect the work of the organization.

In the early years, the administrative tasks required to keep the organization going were completed by board members. As the organization grew, the board realized the need for administrative assistance and hired an Organizational Coordinator in 1990, which has greatly enhanced the professionalism of the organization.

There have been so many extremely dedicated professionals involved in OJACC over the years. Highlights from comments made by the first and second president of the association from one of our very early newsletters exemplify the original goals of OCCO – OJACC that continue today. First president, Richard Billak wrote, “It was only three short years ago that a group of us came together and asked, how can we take control of our own destiny? Some thirty-six months later, the answer seems obvious – by collectively working together.” The second president, James Wichtman wrote, “We have learned that we use our clearest voice and receive attention to what we have to say when we present our message together. This unity is the very purpose of the Ohio Community Corrections Organization’s existence. Though we recognize the importance each stakeholder plays in the delivery of correctional services, we have experienced true strength when we stood together.” Thirty years later, we are still standing together and working toward our mission.

The original founders of OCCO/OJACC were: James Lawrence, Richard Billak, James Wichtman, Candace Peters, and Neil Tillow.

ODRC began presenting the Clifford Skeen Awards at the OJACC Conference in 2007. Each year, OJACC has sponsored up to 10 lunches for each Clifford Skeen Award winning agency at the Awards Luncheon so their staff and stakeholders may partake in this recognition.

In 2006 OJACC, in cooperation with ODRC, created the OJACC Community Corrections Collaborative which consists of community corrections organizations represented by OJACC including (OCCA, OCPOA, CorJus, and CBCA) in addition to representatives from ODRC. This collaborative group works on common initiatives to improve the effectiveness and efficiency of state funded community corrections.

Individual Membership - \$25 Allows an individual in the field of criminal justice or interested citizens to join. Individuals representing private for-profit corporations are excluded from this category

County Membership – Allows *county commissioners, judges, prosecutors, chief probation officers and sheriffs* to join. These offices may designate an employee from that office to represent them. **Five** members from the county receive a \$25 discount for annual conference fees. **A county with a population under 150,000, membership is \$150 and counties with a population of 150,000 or greater, membership is \$250.**

Government or Private Agency – Allows a private, not-for-profit agency to join. Membership extends to the director of the agency or the designated employee. Examples of private agency members are halfway houses, private correctional agencies and child caring agencies. **Three** members from the agency receive a \$25 discount for annual conference fees. **Agencies with a budget of less than \$500,000, membership is \$150 and agencies with a budget of \$500,000 or greater, membership is \$250.**
